

# Model of Central Population Registration for management of e-Identity

**Central population register (CPR)** represents the central repository and processing of data concerning state citizens (and foreigners). This register is the basis for electronic business in central government and for establishing e-Government services which are used by different public bodies(G2G), businesses(G2B) and citizens(G2C) to minimize bureaucratic burdens. Life events data are collected and stored for all citizens and foreigners in the country that have any kind of rights (e.g. voting, right for permanent or temporary residency, social security and education, property and personal rights etc.) or obligations towards the government (taxes).



### Main advantages of Central Population Register:

- Excellent data base for all state Ministries and Agencies, Customs, Police including border, DB of Public servants, Voter lists for Elections: Presidental, National Assembly, EU Parliament, local elections
- Superb Data protection and Data privacy regime
- Main source data base for Health: e-Births, e-Deaths, Universal vaccination of children, health insurance
- Linking CRVS with national identification management systems provides the foundation for good governance and has benefits in all sectors.
- Rreliable and secure verification and centralized management of e-identities.
- Sthrong cryptographic data protection and a high level of confidence in the electronic identity.
- CPR is the primary source of information for the register-based census of population.

#### **NOTIFICATION**

The purpose of the notification is to gather information on births and deaths of citizens and foreigners in the country. These vital facts can be notified by people working in official authorized institutions (such as hospitals, local administrative office etc.), other authorized personnel (e.g. Village Chefs) and immediate family (notifications "in person"). All notifications are gathered in central Civil Registration data base (CR DB) where it is prepared for further registration.

#### **POPULATION REGISTRATION**

The process of notification is followed by registration. The competent officers are authorized to check and validate notified records (in an administrative office or in remote villages) and complete the missing data. The registration of birth or death of person is official once the data is complete, confirmed and saved in register. Civil Registration database (CR DB) also known as Civil Status Register is a storage of all registrations of vital facts that are provided by various official personnel. CR DB is the basis for registration process and establishment of civil state for natural person - citizens and/or foreigners.

#### **VITAL STATISTICS**

National statistic has special obligations related to collecting, processing and analyzing of data and reporting for purpose of analysis, planning and national or international comparing. The mission of national statistic is to provide government bodies, public administration, commercial companies and general public with information on status and trends in economy, demography, social affairs, environment and natural resources. The main data for statistic is stored in **Statistic Database**.
